

## TERMS OF USE AND SERVICES AGREEMENT

**1. Agreement** InfiniTrade, Inc. (hereinafter referred to as “Infinitrade”) is an internet based financial information service that offers foreign currencies (FOREX) and other instrument trading signals to its member clients, (the "Services") through its web sites, Automated Trading Machine™ and Avatar™ signals client. By registering as a member and/or client for these Services, you agree to use the Services under the Terms of Use of this "this Agreement", which can be found on the Infinitrade web site and which apply to all our members and visitors. Please read these Terms of Use and Services Agreement fully, before you subscribe to the Services. InfiniTrade and its affiliates and representatives, reserves the right at any time to change the Terms of Services on this web site at any time, and by your continuing to use the web site and/or the Automated Trading Machine and Avatar signals client thereafter you agree to be bound by the new version of the Terms of Services agreement. If any of the Terms of Use and Services in this agreement are not acceptable to you for any reason, you must terminate your membership subscription. Whenever new Services become available to you or are offered to you, your use of them will fall under this Agreement unless we notify you otherwise. In these Terms, "we" refers to “Avatar” “Trading Machine” or “Automated Trading Machine(s)”, “Infinitrade” and our affiliated products and services and representatives, and the term "Subscriber", “User”, “Member” or "you" refer to you as a registered subscriber to the Services. This Agreement does not create any contractual or other legal relationship between you and Infinitrade or any of its affiliates, other than to provide the Services as described in this Agreement.

**2. Description of Services** Infinitrade offers a unique signals service with “trade assist” functions for various instruments, including FOREX. A member/user subscribes to a trading channel as we call it that trades one or more instruments based on a strategy assigned to that channel. The trading strategy or strategies may incorporate automated computer signal generation using technical indicators and trading algorithms. Some channels may utilize both technical indicator strategies and fundamentals research with human interpretation to control trade direction and entry and exit prices. As a subscriber you pick one or more channels that reflect the degree of risk or the strategy you wish to employ and then assign that channel to your Broker platform. Infinitrade provides an interface to your broker via our Avatar client which interfaces with a Trading Machine assigned to that channel that acts as a bridge to transmit signals to you.

**3. Service Limitations** All contents of the Services are provided for general information purposes only. The Service does not constitute investment advice, an endorsement of any commodity, security, or as an offer to buy or sell any commodity or security.

Infinitrade, Inc is not a registered broker-dealer, or a financial advisor. The services provided do not provide personal investment advice. Infinitrade is a publicly available service that provides information and trading signals, not specific or particular to any individual. Opinions, commentary, remarks, recommendations and other features comprising the Services are for informational purposes only and are provided without warranty of any kind.

If you wish specific investment opinions or would like to participate in a managed account that utilize these Services you will need to hire a Commodity Trading Advisor (CTA) registered with the (CFTC) Commodity Futures Trading Commission who is a member of the National Futures Association (NFA). **4. Membership and Subscription** You will provide us with accurate and complete registration information and advise us promptly of any changes.
